

1. A formalized, prescribed chain of command, beginning at the level of concern, shall be used

PROFESSIONAL OPINION

when;

- 1.1 A physician's order, care, or response to a concern is interpreted as unsafe, conflicting with LLUMC policy, or conflicting with another physician's order.
- 1.2 A physician is not available/does not respond to pages and a physician is needed to address patient needs.
- 2. The person at the next level of responsibility (reference Attachment M-4.A) shall be contacted if a response cannot be obtained within a reasonable length of time. Efforts shall be made at each level to resolve the concern with medical staff.
- 3. The chain of command sequence, as described in Administrative Procedure M-4.A shall be followed for resolution of issues described in # 1.
- 4. If there is no resolution at the attending physician level, the nurse or other professional shall notify the department head/administrative supervisor of the unresolved issue and then proceed up the chain of command.
